A baccalaureate degree in nursing from a regionally accredited or New York State registered four year college or university and licensure and current registration to practice as a Registered Professional Nurse in New York State. <u>ALL CANDIDATES MUST SUBMIT A COPY OF THEIR COLLEGE TRANSCRIPTAND A</u> COPY OF THEIR CURRENT LICENSE AT TIME OF APPLICATION.

<u>SUBJECT OF EXAMINATION</u>: For this position, no written test is required. Candidates will be rated on an evaluation of their training and experience in relation to the duties and requirements of the position. It is essential that candidates give complete and accurate information regarding their training and experience on their applications because one's place on the eligible list will be determined by the rating given in the evaluation.
